

## ELIGIBILITY

- Artists must be 18 years of age or older.
- All pieces must be artist's original design or concept and executed solely by the artist.
- Two pieces may be entered per artist.
- Artwork must be predominantly textile-related, either in materials used or techniques employed.
- Artwork executed under classroom or educational/supervisory guidance are not eligible.
- Artwork may not have been previously exhibited at Textile Center.
- Artwork must be completed after January 1, 2008.

## JURYING

Megan Hatch. Healing Art Program Coordinator for the Penny George Institute for Health & Healing at Abbott Northwestern Hospital in Minneapolis, MN.

Barb Piotrowski. Art teacher, art and design consultant, currently Art Director specializing in healing art and programs with over 30 years experience in the arts.

Audree Sells. Using her years of experience as a painter, Audree has chosen fabric as her medium to create painterly quilts in a variety of subjects, styles and techniques. Many of her works are on display at health facilities around the state.

Jurors will review all images and make the exhibition selections. Jurors will consider design/concept, technique and construction and overall connection to textile/fiber art.

- Please note that the quality of images greatly impacts the juror's ability to assess your work. See reverse for image requirements.

## AWARDS

- \$500 Best of Show
- \$250 Juror's Choice
- \$100 People's Choice

Awards will be presented based on technical excellence and innovative use of materials/textile-related techniques.

## EXHIBITION & SALES

- All accepted artwork must remain in the Gallery for the duration of the exhibition.
- All accepted artwork must be for sale.
- Textile Center retains 40 percent (%) commission on all sales made directly from the exhibition.

## INSURANCE & SHIPPING

- Insurance for artwork is the responsibility of the artist. While reasonable care is taken when handling artwork, Textile Center does not assume any responsibility for loss or damage.
- All costs associated with shipping artwork to and from Textile Center (including transit insurance) are the financial responsibility of the artist.

Deadline for entries: Monday, October 26, 2009  
(Note, this is not a postmark date)

Notification letters to all entrants will be mailed by December 4, 2009

Accepted artwork must be received by April 19, 2010

## APPLICATION REQUIREMENTS

- Entry Fee: \$30 per entry payable in US funds by check or money order or charged to credit card (Visa or Mastercard only)
- Artwork: Maximum of 2 pieces per artist
- Artist Statement: Required; one page maximum relating to each piece submitted
