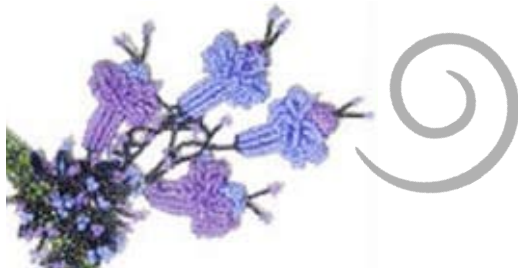


Beads of Whimsy

Glossary of terms:

Materials - List materials used in your piece. For example, "seed beads", "perle cotton", "muslin"

Techniques - Describe techniques used to make your piece. For example, "hardanger embroidery", "peyote stitch beadwork", "needle felted"

Category - Choose a category for your entry from the following:

- Wearable - Jewelry
- Wearable - Other
- Non-Wearable - Flat (wall hanging)
- Non-Wearable - 3-D (sculpture)

ELIGIBILITY

Artists over the age of 18 may submit a maximum of three entries for the \$25 entry fee. Entries should be submitted in one of the following categories:

Wearable - Jewelry

Wearable - Other

Non-Wearable - Flat (wall hanging)

Non-Wearable - 3-D (sculpture)

Artists may submit no more than 2 entries per category.

Pieces must have been completed after January 1, 2007 and contain at least 50% beads. All work must be of original concept and executed by the artist.

AWARDS & SALES

There will be awards in each category (listed above) as well as Judge's Choice and Best of Show awards. Winning entries will be announced at the opening reception of the exhibition.

The Textile Center will retain a 45 percent commission on all sales made directly from the show. The Textile Center also asks a 20 percent commission on sales that result from direct referrals.

DELIVERY AND PICK-UP

All accepted work must be received at the Textile Center by Monday, February 25, 2008 at 4:00 p.m. All pieces must remain at the Textile Center for the duration of the show. Work will be shipped back to artists or ready for pick up after April 12, 2008.

All costs, including insurance, shipping, delivery and return of work are the artist's responsibility.

SCHEDULE

The deadline for entries is 4:00 pm on Friday, November 30, 2007. Please note that this is NOT a postmark deadline.

Jurying will be completed and notification letters mailed to all artists by January 28, 2008.

IMAGES

Please submit a maximum of two images for each piece listed on your entry form.

Digital Images - .jpg format and minimum 350 DPI. Please label images by title and artist last name. Digital images may be submitted on CD-ROM with entry form or via email to gallery@textilecentermn.org. Include artist's name in subject line.

Slides - Marked with the artist's name, title and an arrow indicating proper orientation (which end is "top"). Please do not send original slides.

Color photographic prints are not accepted.

Images accurately representing work and high quality or professional images are required.

Images of accepted work will be kept by the Textile Center for publicity purposes.

APPLICATION

- The entry fee is \$25.00. Please make checks payable to the Textile Center. International entries please call or email for payment information.
- Include a 100-word artist's statement summarizing "What makes your piece whimsical?"
- Enclose a self-addressed, stamped envelope (SASE) for return of images.
