

***A Common Thread is an elite exhibition showcasing the fabulous fiber art of Textile Center members. It is the premiere exhibition to the 2011 Textile Center Gallery season!***

#### **ELIGIBILITY**

- Artists must be 18 years of age or older.
- Applicants must be currently paid (active) members of the Textile Center.

#### **ARTWORK SPECIFICATIONS**

- 2-dimensional artwork must not exceed 28" W x 36" H (wall art).
- 3-dimensional artwork must not exceed 12" W x 12" H x 12" D (requiring pedestal)
- Freestanding artwork (including wearable art) must not exceed 30" W X 60" H x 30" D
- Artwork must have been completed after January 1, 2009.
- Artwork may not have been exhibited previously at Textile Center.
- Artwork must be artist's original design and completed solely by the artist.
- Artist may submit only one piece for the exhibition.
- Artwork must be predominantly textile-related either in materials used or techniques employed.
- Any artwork that exceeds size specifications will be exhibited as space allows.

#### **IMAGES**

- Professional or high resolution digital images accurately representing work are required. Please credit professional photographer by name.
- Images must be minimum 2500x2500 pixels at 300 dpi in jpeg or tif format
- Images must be submitted on CD labeled with artist's name
- Maximum of three images per piece
- Image files must be named in the following format: Artist Last Name + Title + view (e.g. smithartworkfront)
- CD's become the property of Textile Center and will not be returned
- Slides, color prints or snapshots will not be accepted.

#### **SCHEDULE**

- Application deadline is October 4, 2010. (This is NOT a postmark deadline)
- Artwork must be received by Textile Center by January 7, 2011.
- Exhibition dates: January 14, 2011 through February 26, 2011.
- Artwork must remain in the galleries for the entire exhibition.

#### **INSURANCE, SHIPPING & SECURITY**

- Insurance for artwork is the responsibility of the artist.
- While reasonable care is taken when handling artwork, the Textile Center does not assume any responsibility for damage or theft.
- All costs associated with shipping artwork to and from the Textile Center (including transit insurance) is the financial responsibility of the artist.

#### **GALLERY SALES**

The Textile Center Galleries rely heavily on commissions from the sale of artwork. It is preferred, but not required, that artwork be available for sale. If your work will not be for sale, please consider including a designated donation to the Galleries with your entry.

- Textile Center will retain a 40% commission on all sales of artwork from the exhibition.
- Textile Center will retain a 20% commission on all special work commissioned for the artist as a result of the exhibition.
