

SUBMISSIONS

- All pieces must be artist's original concept and executed solely by the artist. (If another designer's pattern is used, credit must be given to the designer; please respect copyright laws.)
- Artwork must be 3-dimensional and have human-like features (e.g. head, hands, feet).
- Artwork must be predominantly textile-related, either in materials used or techniques employed.
- Artwork must have been completed after July 1, 2009.
- No size limitations.
- Artist statement pertaining to work must be submitted in Word document format (half-page per piece max).
- Two pieces may be entered per entry fee.

ELIGIBILITY

- Artists must be 18 years of age or older.
- Artwork executed under classroom or educational/supervisory guidance is not eligible.
- Artwork may not have been previously exhibited at Textile Center.

AWARDS

- \$250 Best of Show
- \$250 Juror's Choice
- \$100 People's Choice

JURY PROCESS

- Jurors: Jodi and Richard Creager
- Jurors will review all images and make exhibition selections.
- Jurors will consider design/concept, technique and construction, and overall connection to textile/fiber art.

EXHIBITION & SALES

- All accepted artwork must remain in the Gallery for the duration of the exhibition.
- All accepted artwork must be for sale.
- Textile Center retains 40% commission on all sales made directly from the exhibition.

INSURANCE & SHIPPING

- All costs associated with shipping artwork to and from Textile Center (including transit insurance) is the financial responsibility of the artist.
- Insurance for artwork is the responsibility of the artist. While reasonable care is taken when handling artwork, Textile Center does not assume any responsibility for loss or damage.

IMAGES

- Professional or high resolution, digital images accurately representing work are required. Please credit professional photographer by name.
- Images must be minimum 2500x2500 pixels at 300 dpi in jpeg or tif format.
- Images must be submitted on CD labeled with artist's name.
- Maximum of three images per piece. (2 full view, 1 detail)
- Image files must be named in following format: Artist Last Name + TITLE + view (e.g. Smith ARTDOLL front)
- CDs become the property of Textile Center and will not be returned.
- Slides, color prints, or snapshots will not be accepted.

SCHEDULE

- Deadline for entries: September 27, 2010 (Note: this is not a postmark date.)
- Notification letters to all entrants will be mailed by November 12, 2010.
- Accepted artwork must be received at Textile Center by March 1, 2011.

APPLICATION REQUIREMENTS

- **Entry Fee:** \$30 per entry payable in US funds by check, money order, or charged to credit card.
- **Artwork:** Maximum of 2 pieces per entry fee.
- **Artist Statement:** Required for each piece submitted.
- **Labeled CD:** Containing images and artist's statement.
- **Entry Form:** available at www.textilecentermn.org

Electronic submissions (via email) will not be accepted, except from artists residing outside of the U.S.

Incomplete entries will not be considered.

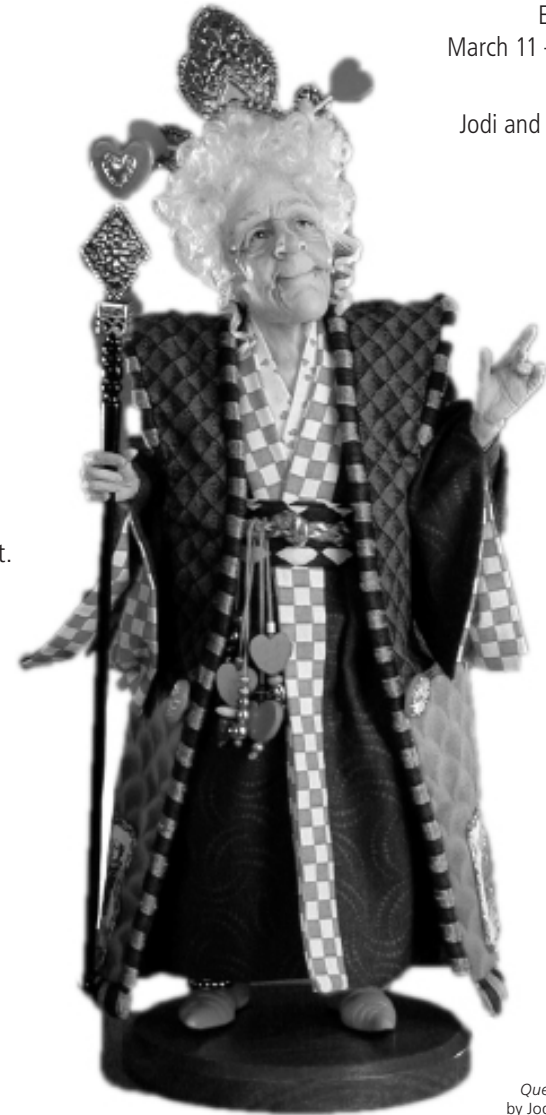
