

SUBMISSIONS

- Artists must be 18 years of age or older.
- All pieces must be artist's original design or concept and executed solely by the artist.
- Materials and/or construction techniques must be fiber or textile related.
- Art must be designed for the human body and displayable on a standard mannequin. (Refer to our website for mannequin measurements.)
- Artist may submit 3 pieces of art per entry fee.
- Artwork must not have been exhibited at the Textile Center previously.
- Artwork must have been completed after January 1, 2008.

AWARDS

Awards will be presented for Best of Show, Juror's Choice and Most Innovative Use of Materials & Technique.

EXHIBITION & SALES

- All accepted artwork must remain in the Gallery for the duration of the exhibition.
- All accepted artwork must be for sale. Textile Center retains 40 percent (%) commission on all sales made directly from the exhibition.

INSURANCE & SHIPPING

- Insurance for artwork is the responsibility of the artist. While reasonable care is taken when handling artwork, Textile Center does not assume any responsibility for loss or damage.
- All costs associated with shipping artwork to and from Textile Center (including transit insurance) is the financial responsibility of the artist.

IMAGES

- High quality or professional images required
- Images must be submitted on CD. CD should be labeled with artist's name.
- Images must be at minimum size of 1000 pixels by 1000 pixels – jpg format required.
- Maximum 3 images per piece (1 full view front, 1 full view back, 1 detail).
- Images must be labeled by TITLE of piece (not number).
- Images will become the property of Textile Center and will not be returned.
- Please test your CD to make sure it is readable.
- Slides, color prints or snapshots will NOT be accepted. Electronic submissions cannot be accepted.

JURYING

Juror: Jacquelyn Rice
Juror will review all images and make the exhibition selections.

SCHEDULE

- Deadline for entries: Monday, November 9, 2009
(*Note this is not a postmark date*)
- Notification letters to all entrants will be mailed by December 21, 2009
- Accepted artwork must be received by May 26, 2010

APPLICATION CHECKLIST

- Entry Fee
\$30.00 per artist, payable in US funds by check or money order or charged to credit card
- Artist Statement
Required; one page maximum, 50 words or fewer per entry, relating to artwork submitted
- CD with Images (see requirements)
- Completed Entry Form

Incomplete entries will not be considered.
